# THE CIVIL AVIATION (DESIGNATED GROUND HANDLING AGENT) ORDER 2008

- 2. Solomon Airline Limited and Pacific Air Express Limited are hereby designated as the Ground Handling Agents for all Scheduled and Non-Schedule International Flight Services in Solomon Islands.

3. The Designated of Solomon Airlines Limited, Legal Notice 96 of 1990 as the sole Ground Handling Agent is hereby revoked.
