### CIVIL AVIATION ACT 2008 (ACT NO 7 OF 2008)

#### WITHDRAWAL OF COMMENCEMENT NOTICE

WHEREAS Gazette Notice No 141 published on the Solomon Islands Gazette No.40 dated 30th April 2009 purports to bring into operation the Civil Aviation Act 2008 (No. 7 of 2008);

WHEREAS the purported exercise of powers are contrary to section 1(2) of the Civil Aviation Act 2008 requiring two sets of commencement dates to be appointed pursuant to that section;

WHEREAS the purported exercise of bringing the Civil Aviation Act 2008 pursuant to Gazette No. 141 mentioned above is the incorrect section to bring the Act into operation;

**THEREFORE**, the Gazette Notice No 141 published on the Solomon Islands Gazette No. 40 dated 30th April 2009 is withdrawn.

Any performance of function or exercise of powers as a result of that notice is invalid and is hereby reversed as the Act had not been brought into operation, and in particular any civil aviation document issued before the 5th day of June 2009 pursuant to the Civil Aviation Act 2008 is void and of no effect.

# TRAFFIC (AMENDMENT) REGULATIONS 2009

IN exercise of the powers conferred upon me by section 82(1) of the Traffic Act, I make these Regulations -

- 1. These Regulations may be cited as the Traffic (Amendment)
  Regulations 2009 and commence upon the date of publication in the Gazette.
- 2. Regulation 4 of the Traffic Regulations is amended in the First Schedule by revoking items 1, 2, 3 and 4 and substituted by the following items -
