LAND BOARD – APPOINTMENT OF MEMBERS

LAND AND TITLES (LAND BOARD) REGULATIONS 2014

IN exercise of the powers conferred by section 260 of the Land and Titles Act (Cap. 133), I make these Regulations –

1. Citation

These Regulations may be cited as the Land and Titles (Land Board) Regulations 2014.

2. Remuneration of Land Board members

For clause 4 of the Second Schedule to the Act, a member of the Land Board must be paid remuneration of \$500 for each day the member attends a meeting of the Board.
