**CUSTOMS AND EXCISE ACT
(CAP. 121)****CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT)
(NO.2) ORDER 2019**

I, Hon. **Harry Kuma**, Minister for Finance and Treasury, under section 7 of the Customs and Excise Act (Cap. 121), make the following Order:

1. This Order may be cited as *Customs and Excise (Import Duties) (Amendment) (No.2) Order 2019* and commence on 1 July 2020.
2. The First Schedule to the *Customs and Excise Act* (Cap. 121), as replaced by Legal Notice No.66 of 2018, is amended:
 - (a) in respect of tariff item “2401.1000”, “2401.2000” and “2401.3000”, by deleting the duty rate of “\$2558.823” per kg and substituting “\$2814.7053” per kg;
 - (b) in respect of tariff item “2402.1000”, by deleting the duty rate of “\$2558.823” per kg and substituting “\$2814.7053” per kg;
 - (c) in respect of tariff items “2402.2010”, “2402.2020” and “2402.9000”, by deleting the duty rate of “\$3,10453” per stick and substituting “\$5.3745” per stick or “\$5274.50 per kg”;
 - (d) in respect of tariff item “2403.1100”, by deleting the duty rate of “\$2558.823” per kg and substituting “\$2814.7053” per kg;

- (e) in respect of tariff items “2403.1910”, “2403.9120” “2403.9930”, “2403.1940”, “2403.1990”, “2403.9100”, “2403.9910”, “2403.9920” and “2403.9990”, by deleting the duty rate of “\$2558.823” per kg and substituting “\$2814.7053” per kg.

**CUSTOMS SAND EXCISE (EXCISE DUTIES) (AMENDMENT)
(NO.2) ORDER 2019**

I, Hon. **Harry Kuma**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

1. This Order may cited as *Customs and Excise (Excise Duties) (No. 2) Order 2019* and commences on 1 July 2020.
2. The First Schedule to the *Customs and Excise Act (Cap. 121)*, as replaced by Legal Notice No. 66 of 2018, is amended by:
 - (a) Deleting the duty rate of “\$185.36” per kg which appears in respect of tariff item E.1(a) and substituting the duty rate “\$203.90” per kg;
 - (b) Deleting the duty rate of “\$0.5209 per stick of \$520.90 per kg” which appears in respect of tariff item E.1(b) and substituting the duty rate “\$0.54695 per stick or \$546.95 per kg”;

- (c) Deleting the duty rate of “\$1505.19 per kg” which appears in respect of tariff item E.1(c) and substituting the duty rate “\$1580.45 per kg”.
