**EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 60) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 60) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each of the following persons may enter Solomon Islands on 1 February 2021 despite the prohibition under regulation 7(1) of the Regulations:
  - (a) Kelvin Ross McDonald;
  - (b) Michael Bentley;
  - (c) Warren Danford Michael;
  - (d) Susan Jean Henry.
- (2) Each of the following persons may enter Solomon Islands on 3 February 2021 despite the prohibition under regulation 7(1) of the Regulations:
  - (a) Daniel Gordon Irvin;
  - (b) Anthony Scott Tripp.

**EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD )(NO. 28) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice 193 of 2020), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID19)(Exemption from Quarantine Period)(No. 28) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Exemption from quarantine period**

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 1 February 2021:
  - (a) Kelvin Ross McDonald;
  - (b) Michael Bentley;
  - (c) Warren Danford Michael;
  - (d) Susan Jean Henry.
- (2) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 3 February 2021:
  - (a) Daniel Gordon Irvin;
  - (b) Anthony Scott Tripp.
- (3) The exemptions under subparagraph (1) and (2) are subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
