EMERGENCY POWERS ACT

**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021
EMERGENCY POWERS (COVID-19) (APPOINTMENT OF AUTHORISED
OFFICERS) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 42(2) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Appointment of Authorised Officers) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Appointment of authorised officers

- (1) The persons specified in the Schedule are authorised officers.
- (2) The appointment of the authorised officers has effect only for the period commencing on and from 14 February 2022 to 22 February 2022.
- (3) The appointment is subject to the conditions and limitations that:
 - (a) the authorised officer's function as an authorised officer is only for the purpose of:
 - (i) facilitating and distributing medical and humanitarian supplies to the provinces within Solomon Islands during the period specified in subparagraph (2); and
 - (ii) assessing community transmission of COVID-19 at hospitals in the provinces and distributing medical equipment and supplies to the hospitals; and
 - (iii) providing air transport to facilitate movement of medical and humanitarian supplies within Solomon Islands; and
 - (b) while an authorised officer, he or she must:
 - (i) wear a face mask; and
 - (ii) practice social distancing; and
 - (iii) wash his or her hands with soap frequently; and

(iv) use hand sanitizer frequently.
