AN ACT

TO APPROPRIATE MONEYS TO THE SERVICE OF THE GOVERNMENT

[25th, October, 1990]

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows.

1. This Act may be cited as the 1990-91 Development Fund Supplementary Appropriation Act (NO. 1) 1990.

2. There shall be issued from the Development Fund of the Kingdom and applied to the service of the year ending the thirtieth day of June, One Thousand Nine Hundred and Ninety One any sum or sums not exceeding one hundred and eighty thousand pa'anga in addition to the amount approved by the 1990-91 Development Appropriation Act 1990, for defraying the charge of the Government of Tonga for such period in the manner expressed in the Schedule to this Act.

3. The Treasurer shall issue and pay such sum or sums of money for the purposes set out in the Schedule not exceeding in the whole the sums respectively as the Prime Minister shall by warrant under his hands direct.

4. The moneys granted by this Act are intended for the services in respect of which moneys will become payable within the financial year ending on 30th June, 1991 and any balance thereof unused at the end of June 1991 shall lapse and not be available for making payment in any subsequent month.

Passed in the Legislative Assembly this 25 day of October, 1990.
