AN ACT

TO AMEND THE FUEL SALES TAX ACT (CAP. 72)

[20th June, 1994.]

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. (1) This Act may be cited as the Fuel Sales Tax (Amendment) Act 1994.
(2) The Fuel Sales Tax Act (Cap. 72), as amended, is in this Act referred to as the Principal Act.
2. Section 3 of the Principal Act is amended by:-
 - (i) renumbering the provision as sub-section (1);
 - (ii) deleting the figure "2s" from paragraphs (a), (b) and (c) and substituting therefore the figure "3s";
 - (iii) inserting the following as sub-section (2):

"(2) The purpose of this 1s increase on the rate of fuel sales tax being for repair and maintenance of roads and shall be deposited into a Separate Bank Account called "Road Maintenance Fund Account".

Passed in the Legislative Assembly this 20th day of June 1994.

'OKU TU'UTU'UNI 'e he Tu'i mo e Fale Alea 'o Tonga 'i he Fakataha Alea 'a e Pule'anga 'o pehē:

1. (1) 'E ui 'a e lao ni ko e Lao (Fakatonutonu) ki he Tukahau Fakatau Lolo 1994.

(2) 'Oku ui 'i he Lao ni 'a e Lao ki he Tukahau Fakatau Lolo (Vahe 72), 'i hono fakatonutonu, ko e Tefito'i lao.

2. 'Oku fakatonutonu 'a e kupu 3 'o e Tefito'i Lao 'aki hono -

(i) toe fakafika 'a e kupu ko e kupu si'i (1);

(ii) tamate'i 'a e fika "2s" 'i he palakalafi (a), (b) mo e (c) kae fetongi 'aki 'a e fika "3s";

(iii) fakahu atu 'eni ko e kupu si'i (2):

"(2) Ko e taumu'a 'o e hiki 1s 'o e tu'unga totongi 'o e tukuhau fakatau lolo ke ngaue'aki ki hono monomono mo tanu'aki 'a e ngaahi hala pule'anga pea 'e tipositi ia 'i he 'akauni Pangike Makehe ko e "'Akauni ki he Pa'anga Monomono Hala".
