Act No. 46 of 2010

AN ACT TO AMEND VARIOUS ACTS TO MAKE THEM CONFORM WITH CHANGES IN CONSTITUTIONAL AND ELECTORAL AMENDMENT ACTS

I assent, GEORGE TUPOU V, 1st October 2010.

BE IT ENACTED by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1 Short title, commencement

- (1) This Act may be cited as the Miscellaneous Amendments (General) Act 2010.
- (2) This Act shall come into force immediately after the Constitution (Amendment) (No. 2) Act 2010 comes into force, except for the amendments to the Electoral Act which are deemed to come into force on 29 September 2010.
