# COMPANIES (AMENDMENT) REGULATIONS 2010

## COMPANIES ACT 1995

*IN EXERCISE of the powers conferred by section 399 of the Companies Act 1995, Cabinet by order, makes the following Regulations —*

### 1 Short Title

These Regulations may be cited as the Companies (Amendment) Regulations 2010.

### 2 Second Schedule Amended

The Companies Regulations 1999, is amended by deleting Part 1 of the Second Schedule and replacing it with the following -
