CUSTOMS DUTY (AMENDMENT) (NO.3) ORDER 2013

CUSTOMS ACT 2007

IN EXERCISE of the powers conferred by section 3 of the Customs Act 2007, the Minister responsible for revenue and customs, with the approval of the Cabinet, makes the following Order -

- 1. This Order may be cited as the Customs Duty (Amendment) (No.3) Order 2013.
- 2. The Customs Duty Order 2008, as amended, imposing customs duty on goods effective from 1 February 2008 and published in the Government Gazette Supplement Extraordinary on 21 January 2008 shall be referred to as the Principal Order.
- 3. The Principal Order is amended by inserting the following new tariff items in their correct chapters and numerical placing:
