CUSTOMS DUTY (AMENDMENT) ORDER 2010

CUSTOMS ACT 2007

IN EXERCISE of the powers conferred by section 3 of the Customs Act 2007, the Chief Commissioner, with the approval of His Majesty in Council, makes the following Order:

- 1
 - (1) This Order may be cited as the Customs Duty (Amendment) Order 2010.
 - (2) This Order shall come into force on 1st July 2010.

- 2 The Customs Duty Order 2008 imposing customs duty on goods effective from 1 February 2008 and published in the Government Gazette Supplement Extraordinary on 21 January 2008 as amended, shall be referred to as the Principal Order.

- 3 The Principal Order is amended by –
 - (a) inserting the following new tariff items in their correct Chapters and numerical placings;

- (c) deleting “15%” from column “Import Duty Rate” of tariff code 3806.20.10 and replacing it with “10%”.
