INCOME TAX ACT (Cap. 68)

INCOME TAX (COURT OF REVIEW) (AMENDMENT) RULES 1992

By the powers conferred on me by section 78(2) of the Income Tax Act, Cap. 68, I hereby make the following Rules for the Court of Review.

1. These Rules may be cited as the Income Tax (Court of Review) (Amendment) Rules 1992.
2. The Schedule to the Income Tax (Court of Review) Rules is hereby repealed and replaced by the following Schedule.

On filing any other notice	-	\$10.00
On filing an affidavit or any other document (each)	-	\$4.00
On sealing a writ of subpoena for a witness	-	\$3.00
