PORTS AUTHORITY ACT 1998 (Section 12 (2))

PORTS AUTHORITY (OVERSEAS VESSELS TARIFF FEES) (AMENDMENT) STANDING ORDER 2002

In exercise of the powers conferred by section 12 (2) of the Ports Authority Act 1998, the Authority issues the following Standing Orders:

1. (1) This Standing Order may be cited as the Ports Authority (Overseas Vessels Tariff Fees) (Amendment) Standing Orders 2002.
- (2) The Ports Authority (Overseas Vessels Tariff Fees) Standing Orders 1999 are in these Standing Orders referred to as the Principal Standing Orders.
2. Order 23.0, 23.1, 23.2 and 23.3 of the Principal Standing Orders are amended as follows:
 - (1) by deleting the "\$6.95 per GT per Calendar year" and replace the "\$0.77" with \$1.80.
 - (2) Order 23.0 to Order 23.3 should therefore be written as follows:
 - 23.0 Local registered vessels either in service or laid-up, vessels holding a current coasting licence, shall pay \$1.80 per GT per month or part thereof in advance.
 - 23.1 Yachts and pleasure craft mooring, local and overseas, shall pay \$1.80 per GT per month or part thereof in advance.
 - 23.2 After the expiry of two months laid up local registered vessels shall pay an additional \$1.80 per GT per month or part thereof in advance.
 - 23.3 After the expiry of six months laid up local registered vessels shall pay an additional \$1.80 per GT per month or part thereof in advance.

'I hono ngaue'aki 'o e ngaahi mafai kuo foaki 'e he Kupu 12 (2) 'o e Lao ki he Ma'u Mafai ki he Ngaahi Taulanga 1998, 'oku 'oatu ai 'e he Ma'u Mafai 'a e Ngaahi Tu'utu'uni Tu'uma'u ko 'eni:

1. (1) 'E ui 'a e Ngaahi Tu'utu'uni Tu'uma'u ko 'eni ko e Ngaahi Tu'utu'uni Tu'uma'u (Fakatonutonu) 'a e Ma'u Mafai ki he Ngaahi Taulanga (Ngaahi Totongi 'o e Ngaahi Vaka Muli) 2002.
- (2) 'Oku ui 'i he Ngaahi Tu'utu'uni Tu'uma'u ko 'eni 'a e Ngaahi Tu'utu'uni Tu'uma'u (Totongi Ngaahi Vaka Muli) 'a e Ma'u Mafai ki he Ngaahi Taulanga 1999 ko e Ngaahi Tefito'i Tu'utu'uni Tu'uma'u.
2. 'Oku fakatonutonu 'a e Tu'utu'uni 23.0, 23.1, 23.2 pea mo e 23.3 'o e Ngaahi Tefito'i Tu'utu'uni Tu'uma'u 'o pehe ni:
 - (1) 'aki hono tamate'i 'o e "\$6.95 ki he Toni Fakakatoa 'e taha kotoa pe 'i he ta'u fakatohimahina 'e taha" pea ke fetongi 'a e "\$0.77" 'aki 'a e \$1.80.
 - (2) 'e hoko leva 'a e Ngaahi Tu'utu'uni 23.0, 23.1, 23.2 pea mo e 23.3 'o e Ngaahi Tu'utu'uni Tu'uma'u, hili 'a e fakatonutonu 'o pehe ni:
 - 23.0 Ngaahi vaka 'oku lesisita fakalotofonua tatau pe pe 'oku ngaue pe tu'u, ngaahi vaka 'oku lolotonga ma'u ha'anau laiseni folau fakalotofonua, kuo pau ke nau totongi kimu'a 'a e \$1.80 ki he Toni Fakakatoa 'i he mahina pe konga 'o e mahina ko ia.
 - 23.1 Tau 'a e Ngaahi 'Iote mo e vaka 'eve'eva, fakalotofonua pe muli, kuo pau ke nau totongi kimu'a 'a e \$1.80 ki he Toni Fakakatoa 'i he mahina pe konga 'o e mahina ko ia.
 - 23.2 Hili 'a e 'osi 'a e mahina 'e ua kuo pau ke totongi kimu'a 'e he ngaahi vaka fakalotofonua 'oku tu'u 'a e \$1.80 kehe ki he Toni Fakakatoa 'e taha ki he mahina pe konga 'o e mahina ko ia.
 - 23.3 Hili 'a e 'osi 'a e mahina 'e ono kuo pau ke totongi kimu'a 'e he ngaahi vaka fakalotofonua 'oku tu'u 'a e \$1.80 kehe ki he Toni Fakakatoa 'e taha ki he mahina pe konga 'o e mahina ko ia.
