COMMUNICATIONS (FEES EXEMPTION) DECLARATION 2020

COMMUNICATIONS ACT 2015

IN EXERCISE of the powers conferred by section 51 of the Communications Act 2015 ("the Act"), the Minister responsible for Communications, hereby exempts all –

- (1) Network Operators from the obligation to pay their network operator licence fees as required under section 36 of the Act from April to June 2020;
- (2) Service Providers from the obligation to pay their registration fees as required under section 43 of the Act from April to June 2020; and
- (3) Ship radio station licensees and Coastal station licensees from their obligation to pay radio spectrum licence fees as required under the Communications Radio Spectrum Rules 2019, from April 2020 to March 2021.
