'I HONO NGAUE'AKI 'o e mafai kuo foaki 'e he kupu 5(3)(a) 'o e Lao ki he Tukupau Ngaue'aki 2003, 'oku fa'u ai 'e he Minisita 'oku ne tokangaekina 'a e tanaki pa'anga hu mai mo e tute, 'i he loto ki ai 'a e Kapineti, 'a e Tu'utu'uni ko 'eni:

1. Kuo pau ke faka'ataa mei he tukupau ngaue'aki 'a e lolo 'o a'u ki he lahi taha ko e voliume koe lita 'e 400 ki he mahina, ki he pamu pe misini vai, ki he palani fakakolo taki taha ki hono tuku atu 'o e vai;
2. Kuo pau ke fakatau mai 'a e lolo kuo tuku atu 'i he palakalafi (1) mei ha fale tauhi'anga lolo 'a ia kuo laiseni ko ha 'elia Kasitomu; pea
3. Kuo pau ke faka'ataa mei he tukupau ngaueaki 'a e lolo pe 'oku ngaue'aki ki he fakalolo vakapuna 'oku hu mai 'e he ngaahi kautaha kuo laiseni ki he fefononga'aki fakalotofonua 'i he 'ataa ma'ae kakai.
4. Kuo pau ke kamata ngaue'aki 'a e Tu'utu'uni ni 'i he 'aho 'o e kasete.

CONSUMPTION TAX ACT 2003

(Section 5(3)(a))

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order:

1. That fuel to the maximum volume of 400 litres per month, per water pump or machine, per village community water scheme shall be exempted from consumption tax;
2. That fuel supplied under paragraph (1) shall be purchased from a fuel depot that is licensed under Customs area;
3. That, lubricants solely for use in aircraft imported by licensed public domestic air transport providers shall be exempted from consumption tax; and
4. That this Order shall come into force on the date of gazettal.
