**EXCISE TAX ACT [Cap 11.04]
(Section 3 (1) (b))**

ORDER

IN EXERCISE of the powers conferred by section 3(1)(b) of the Excise Tax Act [Cap 11.04], the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order -

- (1) That the applicable excise tax to fuel imported by Pacific Energy Ltd and Total (Fiji) Ltd in the total values below be revoked –
 - (a) Pacific Energy Ltd – excise tax totalling TOP\$133,861.23; and
 - (b) Total (Fiji) Ltd – excise tax totalling TOP\$41,810.30.
- (2) That for the avoidance of doubt, paragraph (1) shall be processed as a one off exemption.
- (3) That this Order shall come into force on the date of gazettal.
