### QUEEN'S REGULATION

TO PROVIDE FOR THE VESTING IN THE PRESBYTERIAN CHURCH OF THE NEW HEBRIDES TRUST ASSOCIATION OF CERTAIN LAND IN THE NEW HEBRIDES OWNED BY THE PRESBYTERIAN CHURCH OR AGENCIES THEREOF IN AUSTRALIA AND NEW ZEALAND

MADE BY Her Britannic Majesty's Resident Commissioner in the New Hebrides in pursuance of the powers contained in the New Hebrides Orders. In the name of Her Majesty Elizabeth the Second, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and Her other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith.

Presby erian Church of the New Hebrides Trust Association (Vesting) Regulation 1976 and shall come into operation on a date to be appointed by the Resident Commissioner.

**et**ation

2. In this Regulation, unless the context otherwise requires:-

"Assembly" means the Assembly of the Presbyterian Church in the New Hebrides;

"former owners" means the persons or bodies set out in the First Schedule;

"Trust Association" means the Presbyterian Church of the New Hebrides Trust Association established by subsection (1) of section 3 of the Presbyterian Church of the New Hebrides Trust Association Regulation;

"trust land" means the land and rights or interests in land set out in the Second Schedule.

Vesting of trust land in Trust Association

- 3. (1) Upon the commencement of this Regation, the trust land immediately prior to such commencement vested in the former owners shall without further assurance vest in the Trust Association for the respective estates and interests for which the same is held.
- (2) Subject to the provisions of subsection (3), the Trust Association shall hold the trust land subject to any charges, encumbrances or trusts affecting the same immediately prior to the commencement of this Regulation.
- (3) Notwithstanding the terms of any existing trust, the Trust Association may in its discretion, subject to the approval of the Assembly dispose of any trust land or interest therein on such terms as it may think fit to any New Hebrideans collectively or to any individual New Hebridean or New Hebrideans whether acting in a personal or representative capacity, who appear to the Trust Association to be beneficially interested in such trust land, or to any other person for the benefit of New Hebrideans who appear to the Trust Association to be beneficially interested in such trust land.

Pending proceedings etc.

- 4. (1) Any proceedings or cause of action pending or existing immediately before the commenceme of this Regulation by or against any of the former owners or any person acting as its attorney or otherwise on its behalf may be continued or enforced by or against the Trust Association as it might have been by or against such former owner or such person if this Regulation had not been enacted.
- (2) All deeds, bonds and other instruments and all agreements whatsoever subsisting and enforceable before the commencement of this Regulatical fecting any trust land vested in the Trust Association under section 3, shall be of as full force and effect against or in favour of the Trust Association and enforceable as fully and effectually as if, instead of such former owner or any person acting as its attorney or otherwise on its behalf, the Trust Association had been named therein or had been a party thereto.

Errors etc. in names of former owners 5. For the avoidance of doubt, it is hereb declared that any formal error in or misdescription of the name of any of the former owners in the Register of Land Titles or at the Registry of the Joint Court relative to any part of the trust land shall not serve to defeat the vesting of such trust land under the provisions of section 3.
