JOINT REGULATION 5 of 1948

JOINT (DEFENCE) REGULATION

No. 5 of 1948.

To repeal all unnecessary Defence Legislation made under Article 7 of the Anglo-French Protocol as amended by the Exchange of Notes which came into force on the 8th May, 1940.

- 1. All Defence Regulations made under the powers vested in the Resident Commissioners under the Exchange of Notes which came into force on the 8th May, 1940 (together with all orders made thereunder) except the undermentioned; are hereby repealed:
 - (a) The New Hebrides Defence (Finance) Joint Regulation No. 17 of 1941;
 - (b) The Control of New Hebrides French Currency (Defence) Joint Regulation No. 18 of 1941;
 - (c) The New Hebrides Trading with the Enemy Joint Regulation No. 19 of 1941;
 - (d) The New Hebrides Internees (Management of Property) Joint (Defence) Regulation No. 29 of 1941;
 - (e) The New Hebrides Control of Rents Joint (Defence) Regulation No. 21 of 1944;
 - (f) The Defence Regulation (Increase of Penalties) Amendment Joint (Defence) Regulation No. 17 of 1940 amended hereby by the deletion from Article 1 of references to all Joint Regulations except the New Hebrides Commodities Control Joint Regulations No. 6 of 1939.
 - (g) The New Hebrides Defence Powers Joint Regulation No. 16 of 1940 amended hereby by the cancellation of Articles Nos. 1 to 27 inclusive together with any orders made thereunder.
- 2. In addition, the following Joint Regulations of a Defence character made under Article 7 of the Anglo-French Protocol are hereby repealed:
 - (a) The Censorship Joint Regulation No. 4 of 1939 and all amending Regulations;
 - (b) The Censorship (Secrecy) Joint Regulation No. 13 of 1939;
 - (c) The Stopping of Ships and Aircraft Joint Regulation No. 9 of 1940.
- 3. The New Hebrides Commodities Control Joint Regulation No. 6 of 1939 made under Article 7 of the Protocol, but constituted

a Defence Regulations (Increase of Penalties) Amendment Joint Regulation No. 17 of 1940, shall continue in force.

4. This Regulation may be cited as the New Hebrides Repeal of War Legislation Joint Regulation No. 5 of 1948, and shall come into force on the day of the date hereof.
