

NEW HEBRIDES CONDOMINIUM

JOINT REGULATION

N° 12 of 1974

TO bring into effect the estimates of revenue and expenditure of the Joint Administration for the year 1974.

MADE by the Resident Commissioners under the provisions of Articles 2:2, 5 and 7 of the Anglo-French Protocol of 1914 and of section 5 of the Joint Finance Regulation N° 10 of 1957, after consultation with the Advisory Council and the approval of the Governments of Her Majesty and the French Republic.

Estimates of
revenue and
expenditure

1. The estimates of revenue and expenditure of the Joint Administration for the year 1974 shall comprise -

- (a) revenue to the amount of four million two hundred and five thousand eight hundred and eighty-one pounds sterling (£Stg. 4,205,881) ;
- (b) expenditure to the amount of four million two hundred and five thousand eight hundred and eighty-one pounds sterling (£Stg. 4,205,881) ;

or in each case the equivalent thereof in New Hebridean francs.

Authorisation
of expenditure

2. There shall be issued from General Revenue and other funds of the Joint Administration and applied for the service of the year ending on the 31 st day of December, 1974, sums not exceeding the amount specified in paragraph (b) of section 1 and the same shall be appropriated as set out in the Schedule to this Regulation.

Authorisation
of control of
expenditure

3. The Resident Commissioners may jointly authorise the Condominium Ordonnateur and the Condominium Treasurer to control expenditure and revenue, each according to his responsibilities as set out in Joint Standing Order N° 4 of 1957, within the limits fixed by such authorisation and such expenditure shall not exceed the sums specified in paragraph (b) of section 1.

Citation and
commencement

4. This Regulation may be cited as the Joint Appropriation (1974) Regulation N° 12 of 1974 and shall come into operation on the date of its publication in the Condominium Gazette.
