JOINT REGULATION

No. 16 of 1978

TO PUT INTO EFFECT the Resolution of the Representative Assembly No. 12 of 1978, passed the 5th day of December 1978, to amend the Import Duties (Consolidation) Regulation.

MADE by the Resident Commissioners under the provisions of Articles 2(2) and 7 of the Anglo-French Protocol of 1914 and Articles 28(3) and 30 of the Exchange of Notes made at London the fifteenth day of September 1977, between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic.

Scheduled Resolution put into effect. 1. The Resolution of the Representative Assembly No. 12 of 1978, set forth in the Schedule, is hereby put into effect.

Short title and Commencement. 2. This Joint Regulation may be cited as the Import Duties (Amendment) Regulation 1978 and shall come into operation on the first day of January 1979.

RESOLUTION No. 12 of 1978

to amend the Import Duties (Consolidation) Regulation

The Representative Assembly of the New Hebrides, at its sitting on the 5th day of December 1978 hereby resolves and decides, in accordance with Articles 23 and 30 of the Exchange of Notes of the fifteenth day of September 1977, to adopt the following measures -

Amendment of S4 JR. 52 of 1975

- 1. Section 4 (1) of the Import Duties (Consolidation) Regulation (hereinafter referred to as the "principal Regulation") is amended -
- (a) in subsection (1) by substituting the figure "2%" for the figure "1%"; and
- (b) in subsection (3) by substituting "11%" for the figure "10%" and deleting the reference to Code No. 44.27.

Amendment of \$5

2. Section 5 of the principal Regulation is amended by substituting the figure "2%" for the figure "1%".

Amendment of Customs Tariff

3. In the First Schedule to the principal Regulation Code Nos.87.17 and 87.19 are hereby deleted and a new item is added after Code No.87.24, as follows:

"Motor vehicles for the transport of persons including hearses, ambulances and 4-wheel drive type vehicles other than public service type vehicles (see 87.18) NTB - 87 O2A

87.25 with an engine capacity of 1100cc or less 87.26 with an engine capacity between 1101cc & 1500cc 87.27 with an engine capacity of 1501cc or more".

4. The Customs Tariff set forth in the First Schedule to the principal Regulation is amended in respect of each of the Code Nos shown in the annexe to this Resolution as described therein.

Remission of duty on motor spirit

5. Notwithstanding the provisions of section 4 above, the Government is hereby authorised to remit one third of the specific import duty levied on motor spirit which/for consumption in islands other than Efate and Espiritu Santo.

Concessions for agriculture

6. In order to encourage the development of agriculture, the Government is hereby authorised to approve by decision in Council of Ministers reduced rates for specific import duties.
