JOINT REGULATION

No. 4 of 1978

TO PUT INTO EFFECT the Resolution of the Representative Assembly No. 1 of 1977, passed the sixth day of December, 1977, to make provision for the allowances payable to Members of the Representative Assembly .

MADE by the Resident Commissioners under the provisions of Articles 2 : 2 and 7 of the Anglo-French Protocol of 1914 and Article 28 (3) of the Exchange of Notes of the fifteenth day of September, 1977.

1. The Resolution of the Representative Assembly No. 1 of 1977, set forth in the Schedule, is hereby put into effect.

2. This Joint Regulation may be cited as the Representative Assembly (Members' Allowances) Regulation 1978 and shall have effect from the 29th day of November, 1977.

SCHEDULE

Travelling  
expenses  
within the  
New Hebrides.

1. (a) The return travelling expenses of Members of the Assembly by the most direct route to attend sessions of the Assembly or meetings of any Committee of the Assembly shall be paid in full, in the case of a Committee wherever such meeting may be held.

(b) The Clerk of the Assembly shall, if any Member so requires, make all necessary travel arrangements, including payment of the fares. If a Member wishes to make his own travel arrangements, fares incurred by him will be refunded by the Clerk of the Assembly on production of the appropriate documents showing his expenditure.

Touring expenses.

2. Members representing rural constituencies shall receive reimbursement of touring expenses up to a maximum of 50,000 FNH in each year, and those representing urban areas shall receive reimbursement up to a maximum of 20,000 FNH in each year.

Travelling expenses on overseas missions.

3. Any Member sent upon a mission overseas at the request of the Representative Assembly shall receive reimbursement for his per diem and travelling expenses at rates fixed by the General Committee.

Accommodation and subsistence allowance.

4. Members of the Representative Assembly required, in order to attend meetings of the Assembly or its Committees, to leave their normal place of residence shall receive a daily allowance of 3,000 FNH ; the total amount of allowance payable to Members under this head shall be calculated on the basis of the number of nights spent away from their normal place of residence.

Attendance allowance.

5. Members of the Assembly shall be entitled to receive an attendance allowance of 1,000 FNH for each day during which they attend a session of the Assembly or a meeting of any of its Committees. The payment of the attendance allowance and that provided for in paragraph 4 shall be made by the Clerk of the Assembly at the end of each session of the Assembly ;

Provided that the Clerk of the Assembly may make payment of the same in advance to any Members who so request.

Representation allowance.

6. (a) All Members of the Assembly shall be entitled a representation allowance of 24,000 FNH per annum.

(b) Such allowance shall be paid in two equal sums which shall be payable in June and December in each year.
