### THE IMPORT OF GOODS (CONTROL)(T-SHIRTS AND SINGLETS) ORDER NO.47 OF 1986

An Order to restrict the importation of T-Shirts and Singlets into the Republic of Vanuatu.

IN EXERCISE of the powers contained in section 2 of the Import of Goods (Control) Act No. 19 of 1984 as amended by the Import of Goods (Control)(Amendment) Act No. 12 of 1985, I hereby the following Order:-

### RESTRICTION AS TO THE IMPORTATION OF T-SHIRTS AND SINGLETS

1. No person may import into the Republic of Vanuatu any of the goods which are described and specified under the customs tariff heading as set out in Schedule I hereto without an import licence issued therefor by the Minister.

### APPLICATION FOR A LICENCE

2. An application for a licence in pursuance of this Order shall be made in the first instance to the Department of Industry.

#### FORM OF APPLICATION

3. An application under this Order shall be in writing and shall contain such information as the Minister and or the Department of Industry may in each case require.

### FORM OF LICENCE

- 4. (1) A licence issued under this Order shall be in the form as set out in Schedule 2.
  - (2) The Minister may add to or vary the conditions to which a licence is subject.
