The conditions of this licence are as follows:

- 1. The importer is responsible for payment of all duties, taxes, business licence fees, wharfage fees, etc....
- 2. The licence for Cigarettes and Tobacco Products is for goods imported into Luganville on the island of Espiritu Santo or Port Vila on the island of Efate only.
- 3. The licence may be cancelled at any time by the Minister issuing a notice in writing, however goods consigned at the date of cancellation may still be imported under the term of the licence.
- 4. The Order granting the licence may be revoked in accordance with the Import of Goods (Control) Act No.19 of 1984 (as amended).
- 5. The importer will pay commission on all goods imported under this licence to the Vanuatu Cooperative Federation Ltd at the rate of 4% of the landed costs in respect of cigarettes and tobacco products and 3% of the landed costs in respect of all other items declared to the Customs Department at the time of entry for home consumption.

The payment of this commission shall be made to the Vanuatu Cooperative Federation Ltd and evidence of such payment shall be presented to the Customs Department at the time of clearance of the goods at the port of importation.

- 6. The importer shall complete and submit a monthly return in the format attached herewith.
- 7. The monthly return shall be sent, accompanied by the amount owing to the Vanuatu Cooperative Federation Ltd, P O Box 100, Port Vila.
