

REPUBLIC OF VANUATU

LOTTERIES ACT NO. 9 OF 1989

LOTTERIES (FORMS) REGULATIONS NO. 24 OF 1994

To prescribe forms for the purposes of the Lotteries Act No. 9 of 1989.

IN EXERCISE of the powers conferred by section 32 upon me, I CHARLIE NAKO, Minister of Home Affairs, make the following regulations:-

DEFINITIONS

1. In these regulations, unless the context otherwise requires:-

"Act" means the Lotteries Act No. 9 of 1989 as amended from time to time;

"Minister" means the Minister for the time being responsible for lotteries.

FORM OF APPLICATION FOR A LICENCE

2. (1) An application for the grant or renewal of a license for an instant lottery and or pool betting scheme under section 15c of the Act shall contain the particulars and shall be in Form A as specified in the schedule.

(2) The Minister may require from each applicant further information as he considers necessary.

FORM OF LICENCE

3. Every licence granted under section 15c of the Act shall be in Form B as specified in the schedules.

REFUSAL OF CERTAIN APPLICATION FORMS


4. The Minister may, in his discretion, refuse to accept a form of application:-

- (a) when any fee payable in accordance with the provisions of the Act in respect thereof has not been paid;
- (b) which contains any apparent defect or omission;
- (c) which is not in due form;
- (d) which because of erasures or alterations or otherwise he considers may not be in the condition in which it was originally executed.

COMMENCEMENT

5. These Regulations shall come into force on the date of their publication in the Gazette.
