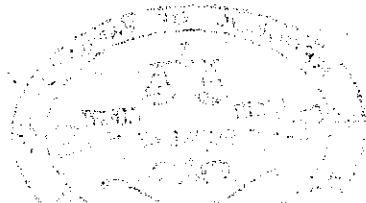

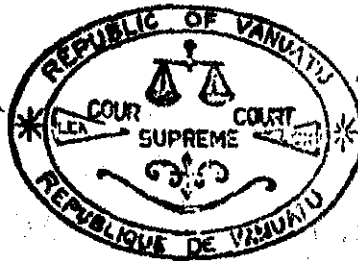

APPOINTMENT OF BAILIFFS

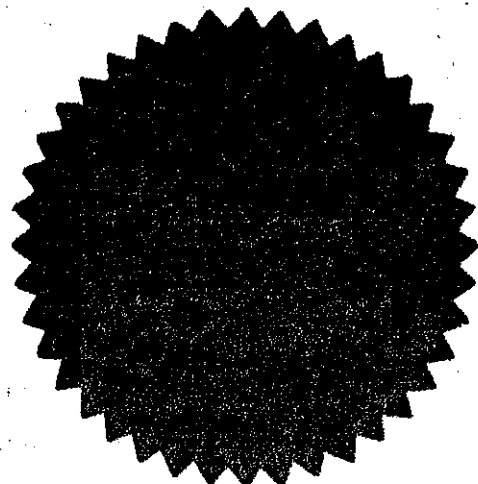
