

IN ACCORDANCE with Section 36 (2) of the Municipalities Act No.5 of 1980, as amended the Luganville Municipal Council hereby publishes a notice of its intention to make the following bye-laws:

  - (3) Control of old, dangerous and unhealthy building Bye-law;
  - (4) Control of the breeding and keeping of farm animals and poultry Bye-law;
  - (5) Food Hygiene Control Bye law and,
  - (6) Charges for covered market (Amendment) Bye-law.
2. Any person who objects to the making of the above bye-laws shall make representations in writing to the Luganville Municipal Council within thirty days from the date of publication of this Notice in the Gazette.
3. This Notice shall take effect as from the date of its publication in the Gazette.
