NAIROBI, 1982

**WHEREAS** the International Telecommunication Convention was signed at Nairobi on the 6 November, 1982;

**WHEREAS** the Council of Ministers of the Government of the Republic of Vanuatu has empowered its Minister of Foreign Affairs and Judicial Services to accede, on behalf of the Republic of Vanuatu, to the said Convention;

**AND WHEREAS** the Republic of Vanuatu is a member of the United Nations and thus qualified to accede to the said Convention in accordance with Articles One and Forty-six thereof.

**NOW THEREFORE,** I, DONALD KALPOKAS, MINISTER OF FOREIGN AFFAIRS AND JUDICIAL SERVICES hereby declare that the REPUBLIC OF VANUATU accedes to the International Telecommunication Convention, Nairobi, 1982, in the 1/8 Unit Class of contribution.

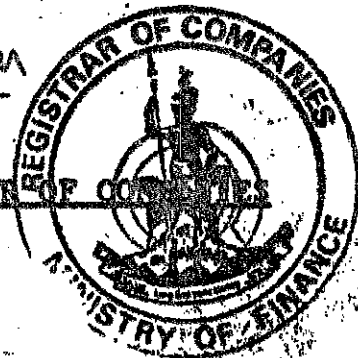

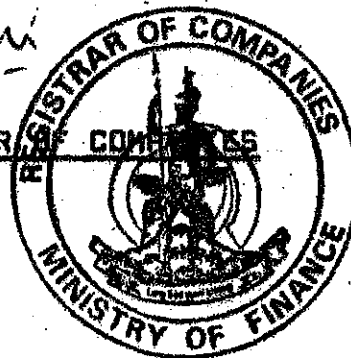


