### CHAPTER 52

#### LIQUOR LICENSING (PROHIBITION) ORDER No. 1 OF 1991

An order to prohibit the sale and supply of liquor in BANKS/TORRES, AMBRYM, PAAMA, EPI, REGIONS and LUGANVILLE Municipal Boundaries in the interest of public peace and good order during BANKS/TORRES, AMBRYM, PAAMA, EPI LOCAL GOVERNMENT COUNCILS AND LUGANVILLE MUNICIPAL COUNCIL ELECTIONS.

IN EXERCISE OF the powers conferred by section 19 of the Liquor Licensing Act (CAP 52), I hereby make the following order:

SALE OF LIQUOR IN BANKS/TORRES, AMBRYM, PAAMA, EPI REGIONS AND LUGANVILLE BOUNDARIES PROHIBITED.

1. Subject to section 2, the sale and supply of alcoholic liquor at licensed premises within BANKS/TORRES, AMBRYM, PAAMA, EPI, REGIONS AND LUGANVILLE MUNICIPAL BOUNDARIES whether for consumption on or off the premises, is hereby prohibited from 7.30 am on WEDNESDAY 23rd day of JANUARY 1991 until midnight Thursday 24th day of January 1991.

## EXCEPTION

2. Notwithstanding the provisions of section 1, alcoholic liquor may be sold during the said period within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with their meals.

This order shall come into force on the 23rd deg of January, 1991.
