IMPORT OF MOTOR VEHICLES (CONTROL)
ACT NO. 30 OF 1992

IMPORT OF MOTOR VEHICLES (PROHIBITION)
ORDER NO. 8 OF 1994

To provide for the prohibition of the importation of right hand drive vehicles.

IN EXERCISE of the power conferred by section 1 of the Import of Motor Vehicles (Control) Act No. 30 of 1992, I, AMOS BANGABITI, Minister of Transport, Public Works, Civil Aviation, Ports and Marine and Urban Water Supply, hereby make the following Order:-

PROHIBITION OF IMPORTATION OF RIGHT HAND DRIVE VEHICLES

1. With effect from 18th April, 1994 no person shall import or cause or permit to be imported into Vanuatu any motor vehicle which is constructed so as to be steered from the right side of that vehicle.

COMMENCEMENT

2. This Order shall come into force on the date of its publication in the Gazette.

AMENDMENT OF PART 1 OF THE SCHEDULE TO CHAPTER 168



to the President 1. 437.504 B(ii)+D+E+G+I+J."

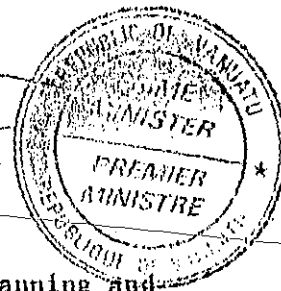
