LIQUOR LICENSING (PROHIBITION)
ORDER NO. 11 of 1995

An Order to prohibit the sale and supply of liquor in Erakor Village, Efate in the interest of public peace and good order during the celebration to mark the 150th year since the arrival of the Presbyterian Church in Efate.

IN EXERCISE of the powers conferred by section 19 of the Liquor Licensing Act [CAP. 52], I, CHARLIE NAKO, Minister of Home Affairs, hereby make the following Order:-


SALE OF LIQUOR IN ERAKOR VILLAGE PROHIBITED

1. The sale and supply of alcoholic liquor at licensed premises within the Erakor Village on Efate, whether for consumption on or off the premises, is hereby prohibited from 6:00 pm on Thursday the 27th day of April, 1995 until 7:30 am on Tuesday the 2nd day of May, 1995.

COMMENCEMENT

2. This Order shall come into force on the date of its signature.
