LIQUOR LICENSING ACT [CAP 52]

Liquor Licensing (Prohibition of sale) Order No.61of 2001

To provide for the prohibition of sale and supply of liquor throughout Port Vila.

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, Joe Natuman, Minister for Internal Affairs, make the following Order:

1 Sale of Liquor in Port Vila

The sale, supply and distribution of alcoholic liquor at, or on, or from licenced premises throughout Port Vila whether for consumption on or off the premises is prohibited from 12 mid-day on Saturday 22nd September to 6pm on Monday 24th September 2001.

2 Exception

Alcoholic liquor may be sold during the period referred to in section 1 within the normal opening hours in restaurants and hotels to bona fide customers for consumption with food.

3 Commencement

This Order commences on the day on which it is made.
