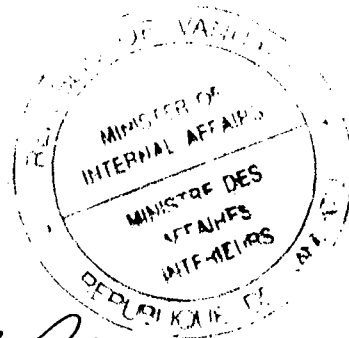


## APPOINTMENT OF MEMBERS OF THE MARITIME APPEAL TRIBUNAL
