1 Deposit

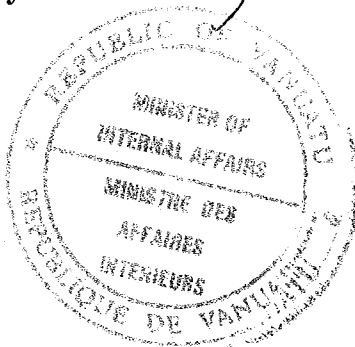

VANUATU INTERACTIVE GAMING ACT NO. 16 OF 2000

Interactive Gaming (Calculation of Tax) Regulation

Order No. 5 of 2003

To prescribe certain rates of tax and deductions

I, the Honourable Sela Molisa, Minister for Finance and Economic Development, in exercise of the powers contained in sections 30 and 44 of the Vanuatu Interactive Gaming Act No. 16 of 2000 make the following Regulation.

1 Calculation of tax

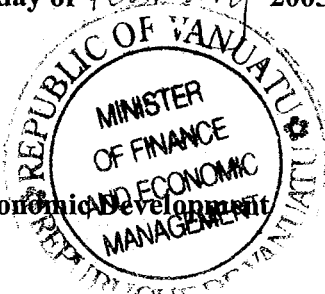
- (1) For the purpose of section 30 of the Vanuatu Interactive Gaming Act No. 16 of 2000, interactive gaming tax is to be calculated at the following rates:
 - (a) 0.1% on a licensee's gross turnover;
 - (b) 2.5% on a licensee's gross profit.
- (2) A licensee is entitled to deduct from the interactive gaming tax that would otherwise be payable for a particular month:
 - (a) bandwidth charges paid by the licensee for that month in excess of \$US0.07 per megabyte; and
 - (b) such bad debts as are declared by the licensee for that month that are due to credit card repudiation and/or dishonoured cheques.

2 Commencement

This Regulation is taken to have commenced on 1 January 2003.

VANUATU INTERACTIVE GAMING
ACT NO. 16 OF 2000

Interactive Gaming (Fees) Regulation
Order No. 6 of 2003

To prescribe certain application and licence fees

I, the Honourable Sela Molisa, Minister for Finance and Economic Development, in exercise of the powers contained in sections 4, 9 and 44 of the Vanuatu Interactive Gaming Act No. 16 of 2000 make the following Regulation.

1 Application fees

For the purpose of paragraph 4(1)(a) of the Vanuatu Interactive Gaming Act No. 16 of 2000, the prescribed fee is:

- (a) \$US 75,000.00 for an application for a licence to conduct all forms of interactive gaming; and
- (b) \$US 35,000.00 for an application for a licence to conduct only sportsbook operations.

2 Licence fees

For the purpose of subsection 9(1) of the Vanuatu Interactive Gaming Act No. 16 of 2000, the prescribed fee is:

- (a) \$US 50,000.00 for the grant of a licence to conduct all forms of interactive gaming and \$US 50,000.00 for the annual renewal of such a licence; and
- (b) \$US 30,000.00 for the grant of a licence to conduct only sportsbook operations and \$US 30,000.00 for the annual renewal of such a licence.

3 Repeal of Order

The Interactive Gaming (Fees and Taxes) Regulation Order No. 22 of 2000 is repealed.

4 Commencement

This Regulation is taken to have commenced on 1 January 2003.

THE ISLAND COURT (POWERS OF MAGISTRATES)

ORDER No.01 OF 2003

An Order to prescribe the powers functions and duties of a Magistrate in respect of matters before an Island Court concerning pending disputes as to customary ownership and boundaries of land.

IN EXERCISE of the powers conferred by Section 2A(1) of the Island Courts Act No.10 of 1983, as amended, CAP 167, I, VINCENT LUNABEK, Chief Justice of the Supreme Court of Vanuatu, hereby make the following Order:

NOMINATION OF MAGISTRATE TO PRESIDE IN CERTAIN LAND MATTERS

1. (1) **Magistrate Hellen Rose Aru** and **Magistrate Ambuse Edwin Macreveth** are hereby nominated to preside over Island Courts on all land matters arising in all areas and districts of Vanuatu, Save that the Magistrate Hellen Aru shall not hear any land cases concerning the Island or people of Ambae/Maewo, and Magistrate Edwin Macreveth shall not hear any land cases concerning the Island or people of Santo/Malo/Aore and connected little Islands in the Sanma Province.

(2) Magistrate Hellen Aru shall undertake responsibility more specifically for the following Islands/regions:

- (a) Tanna
- (b) Erromango
- (c) Aneytum
- (d) Futuna
- (e) Aniwa

Magistrate Edwin Macreveth shall undertake responsibility more specifically for the following Islands/regions:

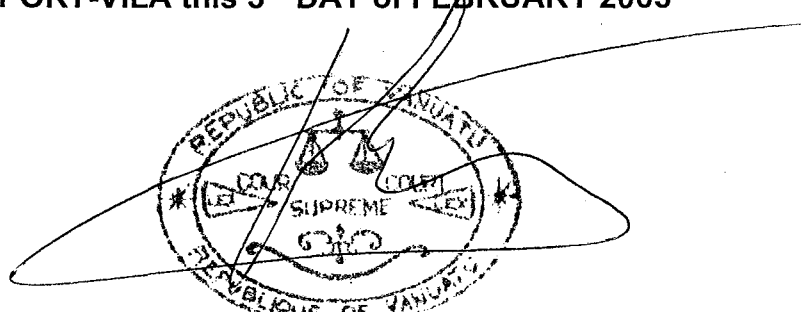
- (a) Efate
- (b) Epi
- (c) Shepherds

(3) Furthermore, they each shall perform their powers, functions and duties pursuant to the Island Courts (Powers of Magistrates) Order No.1 of 1990 as published in the Official Gazette No.1 of 1990.

COMMENCEMENT

2. This Order shall come into force on the date of its signature.

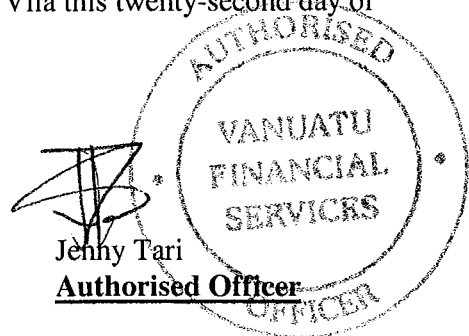



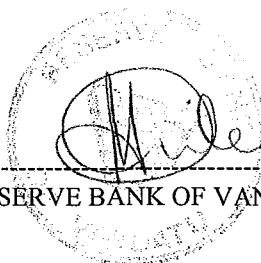
