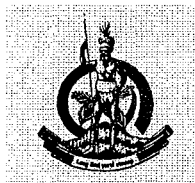

BUSINESS LICENCE ACT NO.19 OF 1998

Abatement of certain business licence fees

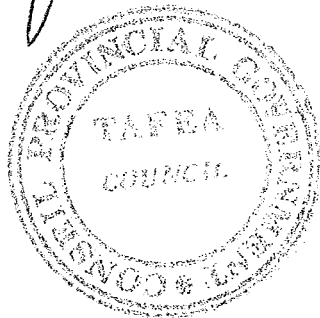
- (a) individuals who live on south and south east Tanna from Isaka to Green Point;
