APPOINTMENT OF COMMISSION OF INQUIRY

ORDER NO. 26 OF 2004

In exercise of the powers conferred on me by Subsection 1(1) of the Commissions of Inquiry Act [CAP 85], I, the Honourable Rialuth Serge Vohor, Prime Minister and Minister responsible for Justice, make the following Order.

1 Definition

In this Order unless the contrary intention appears:

“Commission” means the Commission of Inquiry established under this Order.

2 Appointment of Commissioner to the Commission

Mr Api Jack Marikembo is appointed as the Commissioner to the Commission.

3 Appointment of Assessors of the Commission

The following persons are appointed as Assessors of the Commission:

- (a) Superintendent Willie Samuel;
- (b) Inspector Kelson Bule;
- (c) Sergeant Alick Walter;
- (d) Sergeant Edmon Oswel;
- (e) Kalfau Moli.

4 Terms of Reference

- (1) The terms of reference of the Commission are as set out in the Schedule 1 of this Order.
- (2) The Terms of Reference of the Commission may be amended or varied by the Minister in consultation with the Commissioner.

5 Location of Inquiry

The Inquiry is to be made in Port Vila and at such other place or places as the Commission may determine.

6 Public or Private Inquiry

The Inquiry is to be held in public except in circumstances as directed by the Commission.

7 Reports

The Commissioner must prepare the following reports:

- (a) a report of the proceedings and of the result of his Inquiry to the Prime Minister, as the Minister of Justice not later than 7 October 2004.
- (b) a report summarizing his findings and his recommendations available to the public not later than 14 days after submission of his report to the Prime Minister.

8 Commencement

This Order commences on the date on which it is made.







1 Amendments

The period of campaigning starts is on: Monday 25th October 2004 and closes on Saturday 6th November 2004 at 12 O'clock midnight.

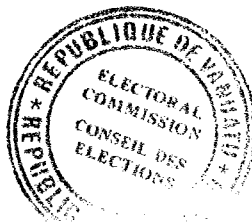

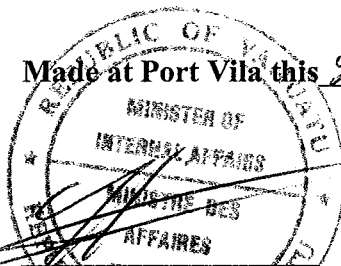

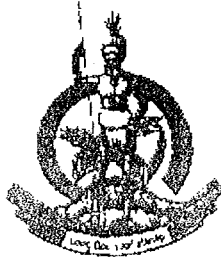
