CONSTITUTION OF THE REPUBLIC

REDUCTION OF SENTENCES

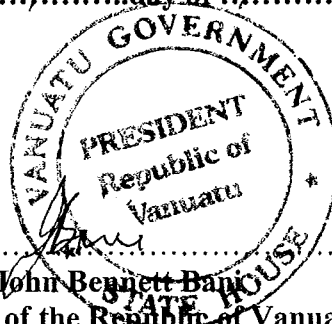

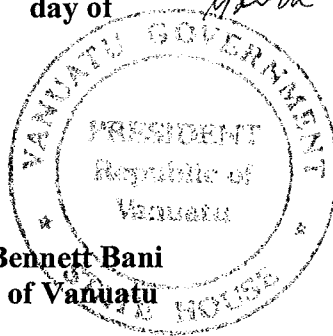
Instrument of Acting Appointment Chairman Public Service Commission
