Prohibition on the Importation of Corrugated Iron Roof (Repeal) Order No. 15 of 2005

In exercise of the powers conferred on me by subsection 2(1) of the Import of Good (Control) Act [CAP 176] and subsection 15(8) of the Interpretation Act [CAP 132] to repeal an Order made under that Act, I, the Honourable JAMES BULE, Minister of Trade, Commerce, Industry and Tourism make the following Order.

1 Repeal

The Prohibition on the Importation of Corrugated Iron Roof Order No. 14 of 2003 is repealed.
