Immigration (Fees) Regulation

Order No. 46 of 2005


In exercise of the powers conferred on me by paragraph 23(1)(a) of the Immigration Act [CAP 66], I, Honourable GEORGE WELLS, Minister for Internal Affairs, after consulting the Minister of Finance, make the following Order:

1 Amendments

The Immigration (Fees) Regulation Order No. 2 of 1989 is amended as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.



SCHEDULE

AMENDMENTS OF THE IMMIGRATION (FEES) REGULATION ORDER NO. 2 OF 1989

1. Repeal

The Immigration (Fees) Regulation Order No. 2 of 1989 is repealed.

2. Fees

The various fees set out in Column B shall be payable, on application, by the applicant to the Principal Immigration Officer for the various matters set out under Column A.

LIQUOR LICENCING ACT [CAP. 52]

Liquor Licensing (Prohibition of Sale) Order No: 47 of 2005

To provide for the prohibition on the sale of liquor within the Port Vila Municipal Council boundary.

In exercise of the power conferred on me by section 19 of the Liquor Licensing Act [CAP. 52], I George Wells, Minister of Internal Affairs, make the following Order:

1. Sale of Liquor prohibited

The sale of liquor in or from licensed premises within the Port Vila Municipal Council boundary whether for consumption on or off such premises is prohibited from 12 midday on Sunday 30th October 2005 to 12 pm on Tuesday 1st November 2005.

2. Exception

Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with food.

3. Commencement

This Order comes into force on the day on which it is made.
