Pursuant to the Article 36(3) of the Convention on the Conservation and Management of Highly Migratory Fish Stocks in the Western and Central Pacific Ocean (WCPFC) the 30 days following the deposit of its Instrument of Ratification has elapsed.

1. Ratification of the Convention on the Conservation and Management of Highly Migratory Fish Stocks in the Western and Central Pacific Ocean

Upon receipt of the Instrument of Ratification to the Convention by the Depositary for the Convention, on 6 October 2005, Vanuatu is now a party to the WCPFC.


2. Commencement






