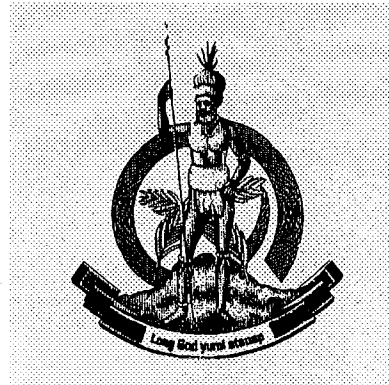

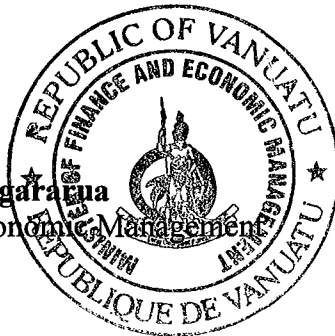

### **Instrument of Appointment of Persons to inquire into certain matters of the Port Vila Municipal Council**

In exercise of the powers conferred on me by paragraphs 61(1) (a) and (c) of the Municipalities Act [CAP 126], I, the Honourable JOE NATUMAN, Minister of Internal Affairs make the following appointment:

#### **1 Appointment**

The following persons are appointed to inquire into certain matters of the Port Vila Municipal Council ("the Council"):

- (a) Luke Shem;
- (b) Peirro Willie;
- (c) Charlot Rory.

#### **2 Terms of Reference**

The terms of reference of the persons appointed in clause 1 are as set out in Annex 'A' of this Instrument.

#### **3 Allowances**

The persons appointed in this Instrument are each entitled to an allowance of VT 50,000 once the report referred to in clause 5 is presented to the Minister.

#### **4 Period on Inquiry**

The Inquiry referred to in this Instrument is to be held for a period of 14 working days commencing on the date on which this Instrument comes into force.


#### **5 Report of Inquiry**

A written report of the Inquiry referred to in this Instrument must be presented to the Minister on or before Wednesday 19<sup>th</sup> of September 2007.

## ANNEX "A"

### TERMS OF REFERENCE OF PERSONS TO INQUIRE INTO CERTAIN MATTERS OF THE PORT VILA MUNICIPAL COUNCIL

To inquire into and report on the following matters:

**(a) Bank Accounts**

To inspect the accounts of the Council held with the commercial banks that operate in Vanuatu or abroad and ascertain the amount received by the Council from the Chantilly's hotel ("the hotel) in relation to the sale of Land Lease Title 11/OE21/024 and to obtain other relevant information relating to such transactions.

**(b) Tender Process**

To investigate the procedures followed by the Council in the sale of Land Lease Title 11/OE21/024 to the hotel and to obtain relevant documents relating to the tender process. This include records and details of other interested bidders and their offers, the procedures on how the Council invited public tender, the closing date for tender, the decision made by the Council to sell Land Lease Title 11/OE2/024 and when that decision was made.

**(c) Other Bidders**

To interview other Bidders and to:

- (i) obtain documents relating to their bids;
- (ii) obtain information on the amounts offered by the bidders;
- (iii) ascertain whether there are any other considerations;
- (iv) identify the dates that their bids were submitted to the Council;
- (v) identify the dates that the bidders were advised by the Council that their offers have not been accepted.

**(d) Agreement made between the Council and the hotel**

To examine and obtain a copy of the Agreement made between the Council and the hotel relating to payment in instalments and payment in kind involving the beautification work that the hotel has agreed to undertake at Fatumauri Bay. To also inspect and verify whether this agreement has been fulfilled and to justify whether the Council is receiving sufficient payment as agreed between the parties.

**(e) Ministry and Department of Lands**

To identify and report on the relevant documents from the Department and the Ministry of Lands relating to sale of Land Lease Title 11/OE21/024.
