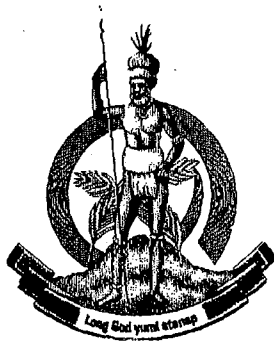

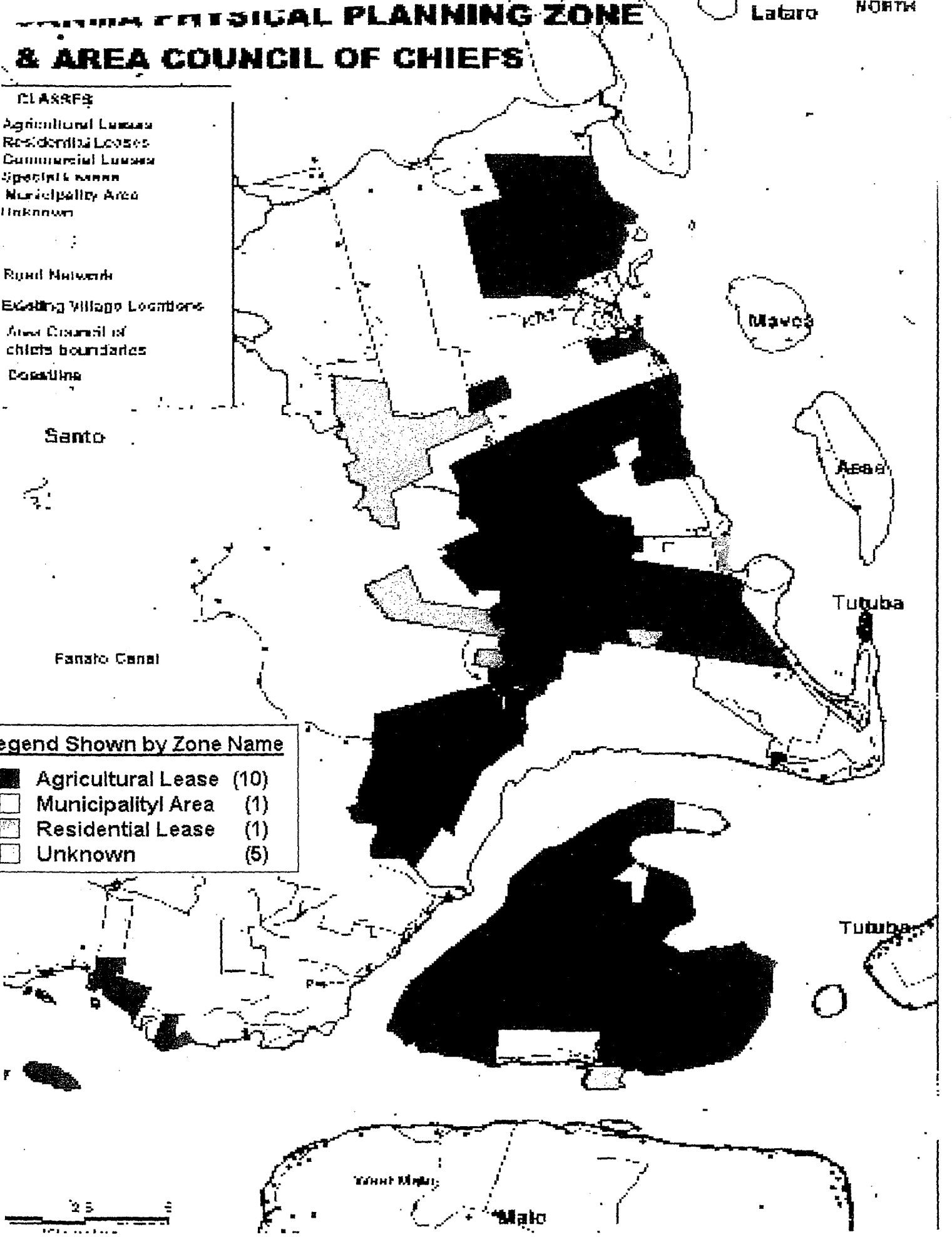
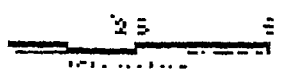

Banban Million Dollar Point Bombua,

sur la grande terre à Santo zones d'aménagement territorial (ZAT) aux fins de développement conformément à la Loi.
