

## Reduction of rate of duty on certain items Order No. 10 of 2008

An Order to amend Schedule 1 of the Act.

In exercise of the power conferred on me by subsection 1(2) of the Import Duties (Consolidation) Act [CAP 91], I, the Honourable WILLIE JIMMY TAPANGARARUA Minister of Finance and Economic Management make the following Order.

#### 1 Amendment

The Import Duties (Consolidation) Act [CAP 91] is amended as set out in the Schedule.

#### **CHAPTER 171**

#### TEACHING SERVICE STAFF RULES (AMENDMENT) NO. 1 OF 2007

To amend the Teaching Service Staff Rules signed on the 16<sup>th</sup> day of July, 1985.

IN EXERCISE of the powers conferred by Section 50 (1) of the Teaching Service Act [Cap.171], the TEACHING SERVICE COMMISSION, makes the following rules:-

#### AMENDMENT OF CHAPTER 6 OF THE TEACHING SERVICE STAFF RULES OF 1985

1. Chapter 6 of the Teaching Service Staff Rules of 1985 in this Rules referred to as the "Principal Rules" is amended by deleting the Teaching Service Staff Rules (Amendment) No. 33 of 1994 Paragraph 6.12. The following paragraphs in Paragraph 6.12 will be deleted:

#### "REMOTE ALLOWANCE"

Paragraph 6.12

- (a) When an officer is posted to a remote place or other selected areas as may be approved by the Commission such officer will be entitled to receive an allowance of VT 5,000 vatu per month.
- (b) An officer who has been transferred from his home island to an urban area or, to another island or to an urban area on home-island will be entitled to receive an allowance of Vt 2,500 vatu per month.

#### **COMMENCEMENT**

These Rules are taken to have come into force on 1st January, 2005.

#### CHAPTER 171

# TEACHING SERVICE STAFF RULES (AMENDMENT) NO. 1 OF 2008

To amend the Teaching Service Staff Rules signed on the 16<sup>th</sup> day of July, 1985.

IN EXERCISE of the powers conferred by Section 50 (1) of the Teaching Service Act [Cap.171], the TEACHING SERVICE COMMISSION, makes the following rules:-

# AMENDMENT OF CHAPTER 7 – HOUSING, OF THE TEACHING SERVICE STAFF RULES OF 1985

- 1. Chapter 7 of the Teaching Service Staff Rules of 1985 in this Rules referred to as the "Principal Rules" is amended as follows:
- (a). Paragraph 7.3 (c)

#### Grade A House:-

Rent = 12% of salary Permanent building furnished to standard as specified in ANNEX III. The house will have main facilities (electricity, water, toilet) and usually be situated in the urban area.

#### (i) Amended as follows:

**Grade A House:-**

Permanent building with indoor kitchen, bathroom and dining room. The house will have the main utilities provided, such as electricity, water and toilet. Rent = 15% to 18% of salary.

#### **Grade B House:-**

Rent = 10% of salary Permanent building furnished to standard as specified in ANNEX III. These houses will not have main facilities (electricity, water, toilet) and will usually be situated in the rural area.

#### (ii) Amended as follows:

**Grade B House** 

Permanent building with kitchen, bathroom and dining room. The house will have the main utilities provided, such as electricity, water and toilet. Rent = 14% to 16% of salary.

#### Grade C House:-

Rent = 8% of salary

Mission type building furnished to standard as specified in ANNEX III. Fairly old building will have some toilet and electricity.

#### (iii) Amended as follows:

**Grade C House** 

Semi-permanent building with kitchen, bathroom and dining room. The house will have the convenient utilities provided, such as water and toilet. Rent = 10% to 14% of salary.

#### Grade D, E and F House:-

Rent = 4% of salary

Fairly good condition bush house with convenient toilet and washing facilities.

#### (iv) Amended as follows:

**Grade D House** 

Traditional building. The house will have access to water and toilet facilities. Rent 6% to 12%.

2. Chapter 7 of the Teaching Service Staff Rules of 1985 in this Rules referred to as the "Principal Rules" is amended as follows:

To delete Annex III: FURNITURE of Chapter 7, of the Teaching Service Staff Rules.

This annex was prepared when most school houses were fully furnished by the colonial government. The school council will be responsible to furnish the house accordingly.

#### COMMENCEMENT

These Rules are taken to have come into force on 1st January, 2008.
