#### 2 After paragraph 12(6)(e)

Insert

- "(f) if the applicant chooses to reside in Vanuatu, he or she must after landing in Vanuatu and for the purposes of the immigration administrative matters:
  - complete and submit a declaration of his or her residential status in the form prescribed under the Schedule of this Regulation; and
  - (ii) must pay a declaration fee specified under item 12B of column D of Table 2 of the Schedule.

(g) The applicant under paragraph (f) must provide to the Principal Immigration Officer the following documents or information:

- his or her written application to the Principal Immigration Officer expressing his or her desire to reside and invest in Vanuatu; and
- a certified copy of the certificate of registration of his or her company with the Vanuatu Financial Service Commission; and
- (iii) his or her proof of income and assets validated by the Vanuatu Financial Service Commission and approved by the Principal Immigration Officer; and
- (iv) his or her receipt of payment of the required fees specified under column D of Table 2 of the Schedule; and
- (v) his or her copy of a certified letter of undertakings from the relevant Vanuatu Trade Commission Office."
