**AN ACT to amend the Betting (Totalisator Agency) Act 1988 to amend the Short Title to that Act, to provide for licensing of persons to act as agents for overseas lotteries, and to provide for incidental matters.**

*[23 July 1991]*

**BE IT ENACTED** by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

**1. Short title**—(1) This Act may be cited as the Betting (Totalisator Agency) Amendment Act 1991 and shall be read together with and deemed part of the Betting (Totalisator Agency) Act 1988 (hereinafter referred to as the principal Act).

(2) Section 1 of the principal Act is amended by omitting the expression "1988" and substituting the expression "1990"

**2. Interpretation**—Section 3 of the principal Act is amended by inserting in their proper alphabetical positions the following definitions:-

"Lottery" includes any game, method or device whereby money or money's worth is distributed or allotted in any manner depending on, or to be determined by, chance or lot, or the result of any race or contest and any place in which lottery tickets are sold procured or distributed shall be deemed to be kept for the purpose of a lottery".

"Overseas lotteries" means lotteries which are conducted outside Western Samoa in accordance with the laws of the state or country within which they are conducted."

**3. Functions of the Board**—Paragraph (c) of section 14 of the principal Act is amended by adding immediately after the word "lotto" the words "in Western Samoa and to provide facilities or agencies whereby persons may participate in lotteries whether such lotteries are conducted within or outside Western Samoa".

**4. General Powers of the Board**—Subsection (2) of section 16 of the principal Act is amended by adding the following paragraph:-

"(d) To act as an agent for overseas lotteries".

**5. Agents for overseas lotteries**—The principal Act is further amended by inserting immediately after section 16 the following section:-

**"16A. Agents for overseas lotteries**—(1) This section relates to and only to licenses issued pursuant to paragraph (d) of subsection (2) of section 16 of this Act.

(2) Any person may apply to the Board for a licence to act as an agent for overseas lotteries.

(3) Unless otherwise prescribed pursuant to subsection (3) of section 16 of this Act:-

(a) a licence shall remain in force for a period of one year but may at the discretion of the Board be renewed from year to year.

(b) a licence shall be subject, in addition to any other conditions which the Head of State may prescribe, to the following conditions:

- (i) The agent for overseas lotteries may only transact business on the premises specified in his licence;
- (ii) The premises and the books and documents kept in connection with the agency shall be open to inspection during normal office hours by any person authorised in that behalf by the Board.

(4) Without limiting the generality of subsection (3) of section 16 of this Act the conditions of any licence may include conditions as to payment of fees or commissions to the Government or to the Board.

(5) It shall be lawful for the holder of a licence to act 'as an agent for overseas lotteries within the terms and conditions of that licence.'

**6. Provisions relating to offices and agencies of the Board—** Section 29 of the principal Act is amended by adding a new subsection as follows:-

"(4) Any person who contravenes the provisions of subsection (3) of this section commits an offence"

**7. Acceptance of bets—** Section 35 of the principal Act is amended by adding a new subsection as follows:-

"(5) Any person who contravenes the provisions of subsection (4) of this section commits an offence"

**8. Persons who may not bet through the Board—** Subsection (2) of section 39 is amended by omitting the words "not exceeding \$200" and substituting the words "in accordance with section 44 of this Act."

**9. Incidental amendments—** The sections to in the first column of the schedule to this Act are amended by making the omissions and deletions appearing opposite those sections in the second and third columns of the said schedule.
