AN ACT to amend the Goods and Services Tax Act 1986

[23 July 1991]

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title and Commencement—(1) This Act may be cited as the Goods and Services Amendment Act 1991 and shall be read together with and deemed part of the Goods and Services Tax Act 1986 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1991.

2. Interpretation—Section 2 of the principal Act is amended by adding the following definition —

“Visitor support facility” means any business which is or has been accepted as a visitor support facility for the purposes of the Enterprises Incentives Act 1984”.

3. Amendments to First Schedule—The First Schedule to the principal Act is amended by adding the following item:

“7. The provisions of any tangible thing or service by every person in connection with the practising of or engaging in any of the following professions or businesses and (except as otherwise herein provided) whether or not such person is professionally or otherwise qualified so to do:

- (a) Accountancy in any of its forms:
- (b) Architecture and the provision of Architectual drafting services:
- (c) Auditing:
- (d) Consulting Engineering:
- (e) Dinsity including dental surgery practiced by a Registered Dental Practitioner:
- (f) Insurance (including the provision of brokeage services) in any of its forms excepting the provision of personal life assurance or superannuation:
- (g) Law in any of its forms:
- (h) Medicine including surgery practised by a Registered Medical Practitioner:
- (i) Pharmacy or Chemist including the provision of pharmaceutical goods provided by a Pharmacist registered under the Pharmacy Act 1976, in respect of the sale of any drug or medicine which is subject to a specific control, or which may only be supplied on production of a prescription, in accordance with any of the following Acts or regulations made pursuant thereto:-
 - (i) the Food and Drugs Act 1967;
 - (ii) the Narcotics Act 1967;
 - (iii) the Poisons Act 1968;
- (j) Surveying:
- (k) Valuations services including the provision of valuations of real and personal property:
- (l) Provision of any service at any hotel, motel, guest house, restaurant, or by any visitor support facility including and without limiting the generality of the foregoing the supply of accomodations, beverages, meals, refreshments, and hire or rental services where the provider or his predecessor has been granted and obtained incentives under the Enterprises Incentives Act 1984 and the services provided by such provider are not included in item 5 or item 6 of this Schedule”
