AN ACT to amend the Head of State Act 1965.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:

1. Short title and commencement—(1) This Act may be cited as the Head of State Amendment Act 1975, and shall be read together with and deemed to be part of the Head of State Act 1965 *(hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1976.

2. Salary and personal expense allowance of Head of State
 The principal Act is hereby amended by repealing section 7 (as substituted by section 2 of the Head of State Amendment Act (No. 2) 1969), and substituting the following new section:

“7. There shall be charged on the Treasury Fund and paid to the Head of State as statutory expenditure—

“(a) A salary at the rate of \$12,500 per annum; and

“(b) A personal expense allowance at the rate of \$2,500 per annum.”

3. Consequential repeal—Section 2 of the Head of State Amendment Act (No. 2) 1969 is hereby consequentially repealed.

2. Totogi ma le alauni o tupe alu tautino o le Ao o le Malo—Ua toe teuteuina nei le Tulafono autu i le soloia o le fuaiupu 7 (e pei ona suia e le fuaiupu 2 o le Tulafono Toe Teuteuina o le Ao o le Malo (Nu. 2) 1969), ma ua suia i ai le fuaiupu fou ua ta'ua i lalo:
