AN ACT to amend the Head of State Act 1965.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title and Commencement - (1) This Act may be cited as the Head of State Amendment Act 1993 and shall be read together with and deemed part of the Head of State Act 1965 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the date upon which it is assented to by the Head of State.

2. Remuneration of Council of Deputies - Section 16 of The Principal Act is hereby amended by:

(a) omitting subsection (1) and substituting following subsection;

"(1) (a) A salary at the rate of \$35,000 per annum;

(b) A non taxable housing and entertainment allowance of \$12,000; and,

(c) A taxable telephone expense allowance of
\$2,400."

(b) omitting the word "refund" from subsection (2)

3. **Official residence for Council of Deputies - Section
16B of the Principal Act is hereby amended by:**

(a) omitting the words "free of charge" and the "comma"
appearing after those words in the third line of
subsection (2)(1); and,

(b) by omitting subsection (2) and subsection (3) from the
section.
