AN ACT to amend the Judicature Ordinance 1961.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title and Commencement - (1) This Act may be cited as the Judicature Amendment Act 1990 and shall be read together with and deemed part of the Judicature Ordinance 1961 (hereinafter referred to as the principal Ordinance).

(2) This Act shall be deemed to have come into force on the 18th day of May 1990.

2. Salaries of Judges - Section 29 of the principal Ordinance is amended by repealing paragraph (a) and substituting the following:

"(a) to the Chief Justice, with effect from the 25th day of May 1990, at the rate of \$75,000 a year.

3. Allowances - Section 30 of the principal Ordinance is amended by adding a new subsection as follows:-

"(3) Payments made under this section and the value of benefits shall unless the Head of State by Order otherwise directs be exempt from taxation and the provisions of paragraph (v) of subsection (1) of section 7 of the Income Tax Act 1974 shall apply accordingly."

1. Igoa Puupuu ma le Amataga - (1) E mafai ona ta'ua lenei Tulafono o le Tulafono o Teuteuga o le Tulafono o Faamasino 1990 ma e tatau ona fai tauina faatasi ma avea o se vaega o le Tulafono o Faamasino 1961 (e pei ona faasinomia mulimuli ane iinei o le Tulafono autu).
(2) O lenei Tulafono o le a tatau ona amata faamamaluina i le aso 18 o Me 1990.
2. Totogi o Faamasino - O le Fuaiupu 29 o le Tulafono autu ua teuteuina i le soloia lea o le parakalafa (a) ma ia sua e faapea:
"(a) i le Faamasino Sili, e amata faamamaluina mai le aso 25 o Me 1990, i le totogi fuapauina e \$75,000 i le tausaga."
3. Alauni - O le Fuaiupu 30 o le Tulafono autu ua teuteuina i le faaopoopaina i ai o le faafuaiupu fou e faapea:-
"(3) O tupe totogi e faia e tusa ai ma lenei fuaiupu ma le aoga o faamanuiaga e tatau ai ae vagana ai ua faatonuina e le Ao o le Malo i luga o se Tulafono Faa-poloaiga e ese mai ai ona tuusaunoaina mai i Lafoga ma aiaiga o le parakalafa (v) o le faafuaiupu (1) o le fuaiupu 7 o le Tulafono o Lafoga 1974 e tatau ona faaaogaina e pei ona o le a talafeagai ai.
