AN ACT to amend certain legislation pertaining to international and off-shore business to increase the efficiency of the administration of that legislation, to grant, where it is perceived to be in the interests of Western Samoa so to do, financial benefits and concessions to persons involved in undertaking business pursuant to that legislation and to amend other Acts for those purposes.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

PART I

Introduction

1. Short Title - (1) This Act may be cited as the Off-

Shore Centre Legislation Amendment Act 1990.

2. Interpretation - In this Act unless the context otherwise requires, -

"The Banking Act" means the Off-Shore Banking Act 1987:

"The Companies Act" means the International Companies Act 1987:

"The Insurance Act" means the International Insurance Act 1988:

"The Trustee Companies Act" means the Trustee Companies Act 1987.

PART II

Amendments to the Companies Act

3. Exemptions and privileges of international companies-

(1) Section 249 of the Companies Act is amended by inserting in paragraph (a) of subsection (2) after the words "registered under part X" the words "except where the income is derived by such company in carrying on business in Western Samoa".

(2) Section 249 of the Companies Act is further amended by repealing subsection (4) and substituting the following subsection :-

"(4) No international company or foreign company registered under Part X shall :-

(a) Carry on business with, or acquire any assets from-

(i) any natural person ordinarily resident in Western Samoa; or

(ii) any domestic company which is not

a trustee company:

- (b) Own an interest in land or real estate situated in Western Samoa other than a lease referred to in clause (e) of subsection (5):
- (c) Make any disposition to or grant or settle any property (including shares or debentures) on-
 - (i) any natural person ordinarily resident in Western Samoa; or
 - (ii) any domestic company which is not a trustee company:
- (d) Make any disposition or grant or settle any property outside Western Samoa in the currency of Western Samoa."

(3) Section 249 of the Companies Act is further amended by adding three new subsections as follows :-

" (5) For the purposes of paragraph (a) of subsection (4) of this section an international company or a foreign company registered under Part X of this Act shall not be treated as carrying on business in Western Samoa with a domestic company by reason only that :-

- (a) it makes or maintains deposits with a company carrying on banking business in or from within Western Samoa:
- (b) it makes or maintains professional contact with solicitors, barristers, accountants,

trustee companies, investment advisers or similar persons carrying on business in or from within Western Samoa:

- (c) it prepares or maintains books and records within Western Samoa;
 - (d) it holds meetings of its directors and members in or from within Western Samoa;
 - (e) it holds a lease of property for use as an office which it has established from which to communicate with members or where books and records of the company are prepared or maintained, or from where it maintains and, being the holder of an off shore banking licence, operates, its business with the approval and consent of the Minister;
 - (f) it holds shares, or debentures or other securities in another company incorporated or registered under this Act: and
 - (g) shares, debentures or other securities in the company are owned by any company incorporated or registered under this Act.
- (6) If an international company or a foreign company registered under Part X of this Act contravenes sub-section (4) of this section it commits an offence against this Act and is liable on conviction to a fine not exceeding one thousand dollars for every day that the offence has continued and every officer of the company who

knowingly permits the contravention is guilty of the same offence and is liable upon conviction to a like fine.

(7) It shall be an offence against this Act for an international company or a foreign company registered under Part X of this Act, or an officer or employee of such company, to take or send, or cause or permit to be taken or sent out of Western Samoa, money or securities which are owned or controlled by a natural person ordinarily resident in Western Samoa or by a domestic company which is not a trustee company."

PART III

Amendments to the Banking Act

4. Interpretation - Section 2 of the Banking Act is amended by adding immediately after the definition of "Residence" the following new definition:-

" "Registrar" means the Registrar of International and Foreign Companies appointed pursuant to the provisions of the International Companies Act 1987."

5. "A" class off-shore banking licence - Subsection (3) of section 6 of the Banking Act is amended by inserting immediately after the words "banking business" where they last appear in that subsection the words "Such approval shall remain in force so long as the "A" class banking licence is valid or until that approval is sooner withdrawn by the Minister".

6. Grants and renewals of licence - Subsections (1) and

(3) of section 9 and subsection (3) of section 11 of the Banking Act are amended by omitting the words "and in accordance with the advice of Cabinet" wherever those words occur.

7. Annual audit - Subsection (1) of section 24 of the Banking Act is amended by omitting after the words "in his opinion" the words "the balance sheet is full and fair and properly drawn up" and substituting the words "proper books of account have been kept and where applicable, proper returns adequate for his audit have been received from branches not visited by him, whether the balance sheet and accounts are in agreement with the company's books, and whether the balance sheet is full and fair and properly drawn up and."

8. Licence fees - Section 10 of the Banking Act is amended by

(a) Repealing subsection (1) and consequentially renumbering the succeeding subsections of that section.

(b) By inserting in each of subsections (2) and (3) (as renumbered) after the words "by due date" the words "and the licensee continues to transact off-shore banking business".

9. Incidental amendments to the Banking Act - The Banking Act is further amended in the manner indicated in the First Schedule to this Act.

PART IV

Amendment to the Trustee Companies Act

10. Pioneer status - The Trustee Companies Act is amended by adding a new section as section 36 as follows:-

"36. Pioneer Status - (1) Where in the opinion of the Minister the operations of a trustee company incorporated or registered under this Act have been or are or are likely to be of unusual and exceptional benefit to Western Samoa in the establishment promotion or advancement of the purposes of any of the Off-Shore Centre Acts then the Minister may direct that such trustee company shall have Pioneer Status for such period not exceeding five years as the Minister may direct, commencing from such time (whether before or after the date of the direction) as the Minister may determine and may issue to the company a certificate to that effect.

(2) The income of a trustee company accruing during the period covered by a Pioneer Status certificate shall be exempt from taxation and the provisions of paragraph (v) of subsection (1) of section 7 of the Income Tax Act 1974 shall apply to that income accordingly.

(3) The Head of State, acting on the advice of Cabinet may by regulation provide that the holder of a Pioneer Status certificate shall enjoy such other concessions and benefits as may seem desirable to assist the establishment promotion or advancement of the purposes of the offshore centre acts.

(4) For the purposes of this section the expression "Off-Shore Centre Acts" means any or all of the following Acts :-

- (a) The Off-Shore Banking Act 1987;
- (b) The International Insurance Act 1988;
- (c) The Trustee Companies Act 1987;
- (d) The International Trusts Act 1987;
- (e) The International Companies Act 1987."

PART V

Amendments to the Insurance Act

11. Interpretation - Section 2 of the Insurance Act is amended by inserting after the definition of the term "domestic business" the following two new definitions:-

"foreign company" means a company registered under part X of the International Companies Act 1987.

"general business" means insurance business that is not long term business, reinsurance business or captive business and without limiting the generality of this term includes marine insurance, engineering insurance, aviation insurance, transportation insurance, motor insurance, property liability insurance, pecuniary loss insurance, credit and guarantor insurance and miscellaneous personal insurance."

12. Incidental amendments to the Insurance Act - The Insurance Act is further amended in the manner indicated in the Second Schedule to this Act.

PART VI

AMENDMENT TO THE INCOME TAX ACT 1974

13. Exempt Income - Section 7 of the Income Tax Act 1974 is amended by inserting immediately after paragraph (o) of subsection (1) the following new paragraph :-

"(oa) Income received by any person whether before or

after the coming into force of this section as an employee of a company registered under the Trustee Companies Act 1987 or licensed under the Off-Shore Banking Act 1987 or the International Insurance Act 1988 where that person is not a Western Samoan citizen and has entered into and remains in Western Samoa solely for the purposes of that employment."

PART VII

AMENDMENT TO THE SHOPS ORDINANCE 1961

14. Exemptions - Section 6A of the Shops Ordinance 1961 (as inserted by the schedule to the Off-Shore Banking Act 1987) is amended by inserting after the words "international company" the words "or foreign company"
